NOTE: Rendering and Certificate of Insurance must be received by January 1<sup>st</sup>. Failure to do so may result in additional charges or no illustration in the guidebook.

### **Rules & Regulations**

**EVENT COMMITTEE:** The event Committee consists of members of the Association assigned to that committee by the Association President and/or Committee Chairperson. All schedules and policies shall be set by this committee.

FINAL INSPECTION NOTE TO BUILDERS: it was determined by the Tour of Homes Committee that the inspection prior to the event will not be performed by the association. It is therefore, the sole responsibility of the builder to finish their model and to ensure the safety of the public to view during the entire event.

**MINIMUM REQUIREMENTS:** Builders are encouraged to have home furnished, but the following are minimum requirements.

- 1. floor covering in all finished rooms
- 2. temporary sidewalks are required
- 3. cleaned and debris removed inside and out
- 4. no unsafe conditions
- 5. final grade required (not finish grade)

**BANNERED HOMES**: Builders who are unable to have their entry completed prior to the start of the event must banner their home. Builders must notify the HBA office by January 1, 2019. A notation will be made in the event guidebook that the home is "not available for showing."

- 1. If the home is completed before the end of the event, the builder will be given their signs and the home may be shown for the remainder of the event.
- 2. Builders who are unsure whether they will be able to complete their entry prior to the start of the event are encouraged to banner their home to avoid possible penalties (see below).

**UNFINISHED HOME ON OPENING DAY:** If the Builder determines that the home is unfinished to view during the opening weekend of the event, the following actions will occur:

- 1. A sign will be posted in the yard of the unfinished entry noting that the home is not available for showing.
- 2. Once the home is completed, it may be shown for the remaining days of the event.

**PENALTIES:** If the Builder does not communicate to the HBA that their model is not finished or sold during the event and therefore, will not be shown during the event, the builder may select which of the following penalties to abide by:

- 1. Refrain from entering homes in the next event.... or
- 2. Pay twice the entry fee amount for all homes entered in the next event.

HOMES WILL BE KEPT CLEAN & MANNED by proper personnel at all scheduled times. Builders are to have homes open 15 minutes prior to the event and 15 minutes after.

INSURANCE: The participant shall obtain and furnish
Certificates of Insurance indicating general liability coverage.

Builder agrees to defend, indemnify and hold harmless St Croix Valley Home Builders Association, Inc., its directors, officers, employees, members and any affiliates from and against any claims, liabilities, losses, suits or expenses, including reasonable attorney fees, arising from or in connection with the Builder's conduct relating to the performance of this contract of

the construction and use of the proposed home.

**PRICES:** Prices quoted at the event home shall be the selling price including all options.

**PRIZE GIVE-AWAY:** If a promotion is provided during the event by the Association, it is mandatory for all builders participating in the event to adhere to the contest/instructions and to follow the given instructions.

**MEDIA ADVERTISING:** Builder is responsible for actions of their selling broker. The Committee will do everything possible to ensure that the Builder receives all possible benefit from the media to better showcase his home.

PROMOTIONS: There shall be no advertising of lotteries, give -away of gifts, or a contest held in conjunction with the SCVHBA event model. The Builder may hand out printed materials that promote the Builder and products used in the model home, but no direct sales of products are allowed. PROMOTIONAL PHOTOS: Any model may be photographed and used for promotion by the event committee without further written permission of the participant.

**RENDERINGS:** Renderings through the HBA will be interpreted by the artist from elevations and floor plans. The Builder holds the artist and HBA harmless in this interpretation of the rendering.

**SECURITY:** Participant agrees to accept the sole responsibility for security of their model, both during construction and while used as a model for the event.

**SELLING HOME/PRESOLD:** If the house is sold prior to or during the event, a permission/authorization form must be signed by the homeowner and be submitted to the HBA office. Occupants of the home may not reside in the home during the event and the home cannot be occupied by the homeowner more than one year before the beginning of the event without written permission by the Event Committee.

**SIGNS:** Signs will be available at the HBA office to be picked up by the Builder on Feb 22, 2019. The official event yard signs are all-uniform and show the Builder's name and event house number. It is the responsibility of the builder to purchase additional signs if needed during the event if they are missing or stolen.

- 1. NOTE: builders may receive recycled directional signs from previous events for Green Build purposes. The participant shall be furnished with six "right/left" directional signs (without stakes if not ordered in contract) to indicate best way to get to event home from the nearest highway or busy street. Builder must follow local ordinances regarding placement of directional signs. Builders are encouraged to remove directional signs during the week, even if local ordinances do not require removal.
- 2. Directional signs must be removed on the last day the model is shown and given back to the association in good condition for 10 Builder Bucks/sign to recycle for next event.
- 3. The only other signs allowed inside the home would be from member firms that are involved with the event home and they must not exceed  $86'' \times 11''$ . Non-member subs or suppliers shall not be allowed, mentioned on signs or other advertising during the event.

**SALES CENTERS:** Sales centers may be entered in the event, if all criteria are met. Contact the HBA office or see the information guide to obtain criteria to enter a sales center in the event.

**DEVELOPMENT SITES:** Builders/Developers may enter their developments in the event for the same price as a model home. Contact the HBA office to receive a separate contract.

**THE FINAL DECISION:** In regards to all matters of general policy of the event shall be made by the Chairperson and the committee. Penalty for violation of above rules may include loss of eligibility for a future event.

#### **Additional Information**

**Event Guidebook produced by E&M Consulting:** For each home entered, there is a 1/2 page 'builder profile' that includes an illustration of the home with home address, description of the home, driving directions to model, builder's name, phone number, and web address, if space is available. Individual maps will not be provided for each model but the area map will be enlarged and more defined.

**Contract:** Builders entering more than one home must submit one contract for each entry. Please notice target dates for specific items. Our event is one of the larger in the state and provides an excellent source of marketing and promotion for our members.

**Renderings:** Builder is required to provide a photo or rendering of each model. Full color 2-D models are available for an additional fee. A full set of blueprints including elevations and floor plans or a front elevation copy must be submitted with the entry to have illustrations done for the builder's section. These prints will not be returned after the rendering is complete. The more information the artist has, the more accurate the drawing will be. Failure to provide a photo, rendering, or blueprints by January 1, 2019 will result with no rendering shown on builder page.

Sales Centers: May be entered in the event if the following criteria are met:

- 1. The development is exclusive to builders who are members of SCVHBA.
- 2. If there are any completed models within the development, each must be individually entered in the event.
- 3. A physical sales center is present. The sales center may be a temporary structure.

#### Advertising in Official SCV Tour of Home Guide:

- The selling for advertisement will be performed by tE&M Consulting.
- 2. All advertisements must be submitted to E&M by their deadlines defined in their promotional marketing brochure that will be provided to all member partners of the SCVHBA.
- SCVHBA reserves the right to refuse ads.

#### **Parade Craze Agreement:**

License. Notwithstanding any other provision of this agreement, builder hereby grants (Enter HBA) a non-exclusive, royalty-free, sub-licensable right and license to use all home details, photos, descriptions, drawings, blueprints, advertisements, etc. provided to (Enter HBA) by builder (collectively, the "Materials") for reproduction, publication, and other use by the (Enter HBA) and authorized third parties for the promotion and operation of the (Enter Event Name) before, during and after the event.

**Indemnification.** Builder hereby represents and warrants that Builder is the owner or licensee of the Materials and that Builder has the right and/or license to provide the Materials to (Enter HBA) for use before, during and after the event as set forth herein. Further, notwithstanding any other provision of this agreement, Builder hereby agrees to hold harmless and indemnify (Enter HBA) from any and all third-party claims, demands, fees, and costs (including reasonable attorney fees) associated with the use of the Materials used by (Enter HBA) in relation to the event.

**Photo Appointment Cancellation.** If a scheduled photography appointment isn't cancelled or rescheduled at least twenty-four (24) hours in advance of the scheduled time, Builder agrees to pay a \$50 cancellation fee. This fee also applies if a Builder, or associated representative, fails to show up to a scheduled appointment or if the home is not properly prepared or suitable for a photo shoot.

## **Contract Acknowledgement**

This contract, including rules and regulations, consists of the entire agreement between parties and may not be amended without the written consent of the builder and the St Croix Valley Home Builders Association. The event committee reserves the right to decline or prohibit any home entry not in character of the general event regulations. The undersigned, as a builder participant in the event, agrees to abide by the rules and regulations of St Croix Valley Home Builders Association as contained herein and any created by the event committee in the future. The undersigned further agrees in the event of a dispute regarding any of the regulations, to accept the decision of the event committee as final. Participating builders agree to defend, indemnify and hold harmless the St Croix Valley Home Builders Association, its directors, officers, employees, members and any affiliates from and against any claims, liabilities, losses, suits or expenses, including reasonable attorney fees, arising from or in connection with the builder's conduct related to this contract, the event or the construction and use of the proposed home.


